How do I know if this provider is right for my charity?

Every organisation is unique in terms of its structure, geography, reach, size, the people it works with and how and there may be a greater or lesser experience in safeguarding work.

Even a charity that is confident in their safeguarding practices, may be newly challenged. For example, a safeguarding incident may have occurred, funders or commissioners may have requirements, growth may leave gaps in capacity, systems and practices may need reviewing and changes to legislation or statutory guidance could mean that training or procedures need to be refreshed, and importantly, Trustee's need to have good oversight.

Your challenges will depend on where you are at and during an early discussion, we can explore what advice and support you need, and you remain fully in control of the process.

Input Needed

The most important input will be from CEO, senior staff and/or trustees involved in the leadership of the organisation and commit to giving time.

They will need to be involved at the start, to ensure they provide a good understanding of their situation. They will need to commit to an agreed plan of work and be available to offer clarification and answer questions that may arise. At the end of the work, they would need to consider any recommendations and feedback on implementation and any impact.
